- ✓ A FAFSA is considered valid if:
  - No federal student loan(s) in default
  - Completed FAFSA including an EFC (Expected Family Contribution) below 15,275
  - Registration of Selective Service verified (male applicants)
  - Proof of U.S. citizenship verified
  - Social Security number verified
  - No drug convictions within certain time limits
