- The pathway building project is on track for completion. Groundbreaking will take place in The Spring of 2026.
- Ogden-Weber Technical College will be celebrating our 55th anniversary in 2026.
- President Taggart shared that the t-shirts ordered for the pioneer days rodeo were a success.
