Ogden-Weber Technical College (OTECH) signed and returned the Certification and Agreement to the Dept. of Education (DOE) on April 17, 2020 to accept allocated funds from the American Rescue Plan (ARP), Public Law 117-2. The ARP established and funded the Higher Education Emergency Relief Fund to provide emergency financial aid grants. These critical funds help eligible DOEU students cover expenses related to unanticipated travel, additional technology requirements, or other needs related to an emergency situation.

METHOD USED TO DETERMINE WHICH STUDENTS RECEIVE EMERGENCY FINANCIAL AID GRANTS AND HOW MUCH THEY RECEIVE

Student grant evaluation process:

- This quarter was focused on contacting students from the same pool of eligible students that were distributed in Q1. With limited funds left, the 52 that were in process were completed and three other students responded with an acknowledgement from the 497 eligible.
- Be an enrolled adult student with an active schedule between 07/01/22 09/30/22
- No OTECH progress and attendance or program restrictions
- Completed FAFSA or a completed OTECH Income Statement form when needed
 - o 'Completed' means that statement of family size, income, and any changes in those two criteria between 2019 and now, have been reasonably verified by OTECH systems or staff.
 - o No other typical restrictions (i.e. loan default status, citizenship, drug conviction, etc.) indicated by submitted FAFSAs applied to eligibility for HEERF grant.
- EFCs of completed FAFSAs are reviewed in consideration of 'exceptional need' criteria
 - o Dependent students with an EFC of 10,451 or less meet criteria
 - o Independent students with and EFC of 15,140 or less meet criteria
- Students' enrollment status determines maximum amount of grant
 - o Students can receive a max of \$1,845.
 - o Previous HEERF payments were considered and subtracted from a student's max eligibility.

Results:

- 497 eligible (reported in Q1)
- 143 awarded / 52 in process (reported in Q1)
- 52 in process acknowledged and received distribution
- 3 additional acknowledged and received distribution
- 5 students received funds from the remaining student funds, 50 students were distributed from institutional funds

The final distribution of funds from student and institutional funds were given to students in May 2023.
